ALL LEAGUES MUST BE WAMO SANCTIONED and all League matches must have been played on WAMO Pool Charter Holder tables.

1. Verification by WAMO Pool Charter Holder (Operator) is required. Players must have played in at least nine (9) league matches on different dates from 8/15/2017 to the tournament entry deadline. All players must be 21 years of age.
2. Women's Division (4 players) All players listed on a team's roster must have qualified within the same Operator League System. .
3. Women's Open teams must be all Open players -- NO Intermediate or Master players allowed.
4. **You may make roster adjustments to your team at the tournament. This adjustment to your roster must be made by 10:00AM Fri., March 9th. \$40 (cash only) per adjustment will go to the WAMO Scholarship Fund.**

2. Entry fees must be made payable to your local WAMO Pool Charter Holder. All entries include a \$5 administration fee. Late entries will be accepted with a late fee of \$50 if space is available
3. WAMO Pool Charter Holders must include Team and Individual League Statistics with each entry form.

If team adjustment is required after the event, all players on the roster will be adjusted.

To be in the Tournament Players Area, you must be 21 years or older.

WOMEN'S OPEN TEAMS must be present and ready to play at NOON Friday, March 9th. Play resumes Saturday and Sunday at 8 AM. Prelims are Round Robin, Finals are Double Elimination
